- I. National Office Updates and Issues
  - a. Rho Chi will recognize advisors' years of service this year with a gift sent in the mail and listed in powerpoint slides distributed in business materials for the annual meeting.
    - i. 5 years, Years of Service Certificate
    - ii. 10 years, Rho Chi Journal
    - iii. 15 years, Rho Chi Letter Opener
    - iv. 20 years+, Engraved Clock
  - b. Recommend increase in member dues to \$100 will discuss and vote at next Executive Council meeting on Saturday, March 21, 2020.
    - i. Options to help students pay dues if unable
    - ii. Offer a payment plan (university or through national office?)
    - iii. Case: faculty has offset cost of membership dues as a sponsor for student
  - c. Continuing application process for National Office to become 501c3 organization.
  - d. Recommend Commercial Sponsorship for centennial events only. Suggestions by council members were CVS or community pharmacy, not pharmaceutical sponsors. Vote on March 21, 2020.
  - e. Future discussion on other publication opportunities of Lecture Award presentation. We will post on our website and social media. Karen Farris will gather more information from AJPE about submitting articles that are not peer reviewed. Open to suggestions of other places to post presentation each year.
  - f. Investment Committee Karen will be forming an investment committee in spring 2020, if you are interested in participating please email her <a href="mailto:kfarris@med.umich.edu">kfarris@med.umich.edu</a>. The committee will recommend ways to manage investments and create an investment policy for The Rho Chi Society. Consideration to establish a Treasurer position.
